### POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 19 JULY 2006

At the annual general meeting of Next Media Limited (the "Company") held at the Conference Room on the 1st Floor, 3 Chun Kwong Street, Tseung Kwan O Industrial Estate, Tseung Kwan O, New Territories, Hong Kong, on 19 July 2006 at 11:00 a.m. (the "AGM"), a poll was demanded by the Chairman of the meeting for voting on all the proposed and seconded resolutions, as set out in the Notice of AGM dated 26 June 2006.

As at the date of the AGM, the issued ordinary share capital of the Company was 1,491,828,881 shares of HK\$1.00 each, which was the total number of shares entitling the holders to attend and vote for or against all resolutions. There were no restrictions on any shareholders casting votes on any of the proposed resolutions at the AGM.

All the resolutions, which were voted on by poll, were approved by shareholders of the Company. The vote-taking at the AGM was scrutinized by the Company's Share Registrars, Computershare Hong Kong Investor Services Limited. The poll results in respect of the resolutions were as follows:
